Dear Senators Schumer and McConnell:

We are writing to call your attention to the large number of judicial vacancies at the District of Columbia courts and ask that you act expeditiously to fill them. As of today, there are twelve open seats on the Superior Court of the District of Columbia and—with yesterday's confirmation of Judge Loren AliKhan to the United States District Court for the District of Columbia—two on the District of Columbia Court of Appeals. These vacancies represent roughly *one quarter* of all seats on our courts. This number will only grow as more judges are expected to retire.

There are eight nominees currently pending in the Senate to fill existing DC judicial vacancies. It is vital that you move quickly to confirm these nominees. Understaffing in the courts has had significant impacts on our judicial system, including delays in the administration of justice and an overburdening of our judges with untenable caseloads. Given the interest Congress has shown recently in the District's public safety challenges, filling these vacancies should be a high priority and are a key to our strategy for our shared goal of improving public safety.

All of the pending nominees are well qualified and have been vetted and approved by the independent DC Judicial Nomination Commission and the Biden Administration. Seven of them have also been approved by the Homeland Security and Governmental Affairs Committee. We urge you to schedule votes for all of these nominees before the end of the current Senate session.

Finally, while Homeland Security and Governmental Affairs Committee Chairman Peters and some of his predecessors have made moving DC judges a priority, we stand ready to work with the Senate to find a more expeditious way to process DC judicial nominations. Ensuring these local judges can be examined and confirmed quickly will help ensure the District of Columbia courts can administer justice efficiently and effectively and will aid in recruiting the best candidates possible.

We appreciate your attention to this urgent matter.
